3. Supervising the General Director by the Board of Directors :

3.1. The Board of Directors has fully and diligently exercised its powers and responsibilities in accordance with the Board of Directors' Operating Regulations. The members of the Board, based on their assigned tasks, have led, directed, and supervised their respective work areas; reviewed matters within the Board's authority; and issued resolutions and decisions. Through these efforts, the Board of Directors has effectively directed, supervised, and promptly guided the activities of the Board of Managements. Specifically, the Board of Directors has:

a) Reviewed and issued resolutions, decisions, and directives on matters related to business activities, investments, financial operations, transactions with related entities, salaries, personnel management, and internal regulations of the Corporation based on the Proposals and reports of the Board of Managements;

b) Monitored and overseen the business operation process through documents, reports, and Proposals from the Board of Managements to the Board of Directors;

c) Participated in planning meetings of the Board of Managements and affiliated departments and units to understand the situation, identify challenges and obstacles in business operations, and promptly collaborate with the Board of Managements to devise solutions;

d) Successfully organize the 2025 Annual General Meeting of Shareholders, elect 01 additional member to the Board of Directors of the Corporation for the 2021-2026 term;

3.2. The Board of Directors has directed and supervised all activities of the Corporation in accordance with the resolutions of the General Meeting of Shareholders; and directed the Executive Board in the management of the Corporation's business operations through resolutions, decisions, and regular meetings.

The resolutions and decisions of the Board of Directors were issued in accordance with the authority and responsibilities of the Board and of the Chairman of the Board, as stipulated in the Corporation's Charter on organization and operation, the internal corporate governance regulations, and the Board of Directors' operational regulations.

3.3. Based on the resolutions of the Board of Directors, the General Director has implemented tasks across various areas, including business operations, development investment and restructuring, financial management, and human resources, through the issuance of conclusions and directives at monthly executive meetings and quarterly reviews (monthly reports, Q1 report, and the semi-annual report for the first half of 2025, and the 2025 annual report).

On that basis, the Board of Directors convened regular and extraordinary meetings and issued resolutions to assess the performance of assigned tasks and to formulate the work program for the upcoming quarter.

3.4. Preparation of contents and organization of the 2025 Annual General Meeting of Shareholders and implementation of its resolutions::

a) Approved the Annual General Meeting documents for subsidiaries and associates in 2025, and instructed the Corporation's capital representatives to exercise voting rights at the General Meetings of Shareholders and Members' Council meetings;

b) Based on Resolution No. 52/NQ-VNS dated April 28, 2025, approved by the 2025 Annual General Meeting of Shareholders, the Board of Directors directed the Executive Board to implement the Corporation's 2025 business and investment plan along with other important matters.
